Paving the Way also includes direct client assistance for transportation related expenses pertaining to employment through a grant from the Community Foundation of the Ozarks called Let's Get to Work! Live 2 Give Hope assisted 34 clients with vehicle repairs, tires, registration assistance, fuel, cab vouchers & other transportation related expenses through the Lets Get to Work! grant.
